A disciplined approach to commodity investing.


The Fund: The Fund's rules-based, top-down process seeks to take advantage of certain quantitative and behavioral characteristics of the commodity markets.


The Approach: The Fund offers a broad-based commodity exposure across 32 commodities that make up the index. This is delivered through a system of target weights and rebalancing bands, which systematically rebalance the portfolio back to these target weights. This disciplined process captures a "rebalancing alpha" 1 independent of any forward looking views.

The Features: Commodities have historically provided investors with a hedge against inflation, as well as returns that are uncorrelated to more traditional asset classes, such as stocks and bonds.

A hedge against inflation, and diversification for a portfolio.<sup>2</sup>

Commodities have shown a high correlation to inflation, but negative correlation to stocks and bonds. Not based on the return of any specific fund. (January 1973-December 2023)

Ratings: The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history.
